Coquitlam, GVRD Organizing Hazardous Waste Drop-off

If you've been waiting for an opportunity to dispose of common hazardous products such as paint, old automotive batteries, propane cylinders or aerosol cans, to name just a few, circle the dates of Saturday, October 27 and Sunday, October 28 on your calendar.

These are the dates on which the District of Coquitlam and the Greater Vancouver Regional District are joining forces to provide Coquitlam residents with an opportunity to dispose of household hazardous waste.

Coquitlam, surrounding municipalities and the GVRD will jointly facilitate a collection of household hazardous waste on the October 27–28 weekend. Residents are asked to take hazardous products to the current B.C. Transit development site at the corner of Barnet and Lougheed Highway.

Hazardous materials will be sorted at the drop off site. The provincial government will be responsible for the transportation and disposal of the materials.

Further details will be advertised in local community newspapers prior to the collection weekend.

GARDEN WASTE **CLEAN-UP** SCHEDULE SET

A Fall Clean-Up period for the collection of garden waste has been scheduled Oct. I-I2 to help offset the banning of backyard burning in Coquitlam.

The Fall Clean-Up will be for garden waste - leaves, weeds, branches, grass, tree and plant clippings. Items other than garden waste are not acceptable and will not be picked up.

Collection will be on your regular garbage pick-up day.

However, garden waste will be picked up separately from your regular garbage, the same day but not at the same time. Place your garden waste near to but separate from your regular garbage and tie in bundles one metre by one-half metre.

Remember, batteries, paints and other difficult-to-dispose-of items can be dropped off at the household hazardous waste collection area in October (see page I).

Council Adopts Tree Cutting Bylaw

Coquitlam has moved to protect and preserve environmentally sensitive lands through enactment of a 'tree cutting' bylaw.

Bylaw 2169, adopted by Municipal Council on June II, states that no person may 'cut, alter, remove or in any way trim, prune, defoliate or tamper' with trees within a designated tree cutting permit area without first having applied for and obtained a tree cutting permit.

The bylaw applies to areas which may be subject to flooding, erosion, landslip or avalanche.

Copies of the bylaw and corresponding maps of the protected areas are available at the clerk's office in Municipal Hall.

Water Quality Testing Under Way

In today's environmentally conscious society, clean water is just as important as clean air.

The District of Coquitlam thinks

so and for this reason has embarked on a water quality study of both Como Lake and Lafarge Lake.

Coquitlam has commissioned



Norecol Environmental Consultants of Vancouver to undertake the survey. Initial water samplings were taken in early August with a second series of tests to be undertaken later this year.

The study will show any water quality changes which have taken place in Como Lake and provide important data about Lafarge Lake, including sediment accumulation and determining if development is causing excessive siltation of the lake.

Resident managers and owners of multiple-family dwellings are presently being contacted to invite their participation.

The new service will begin as soon as bin locations are established and the required containers delivered.

Outdoor Burning Restricted

Tough new regulations have all but eliminated outdoor burning in the District of Coquitlam.

In adopting a bylaw to amend the District's existing fire bylaw, Municipal Council recently served notice that random outdoor burning is a thing of the past.

The bylaw further states that no person will be allowed to 'burn any construction or demolition debris, brush, stumps, slash and like material resulting from the clearing of land or any similar materials which would, in the opinion of an Officer, produce heavy black smoke.'


Plan to Attend Recycling Forum

Composting Helps Reduce Waste



Reducing the amount of refuse going into the general waste system is important to all of us.

Recycling is one way of achieving this goal.

Home composting is another.

While some residents have practiced home composting for years, others have started only recently.

Composting organic waste in your backyard not only helps dispose of solid waste but also provides you with a rich soil conditioner.

Almost any organic material — plant trimmings, leaves, weeds, and kitchen wastes such as vegetable and fruit peelings, coffee grounds, tea

leaves, egg shells and even floor sweepings and wood ashes — is suitable for composting. Grass clippings should be mixed thoroughly into composting materials.

Not recommended for open composting are ripened weeds, fats and cooked foods, meat or bones.

The best location for a compost pile is a convenient spot which receives about equal amounts of sunshine and shade during daylight hours. In areas where racoons or rodents are a problem, it is best to put a concrete slab or large patio stones under the compost box, line the box with wire mesh and cover with a tight-fitting lid.
