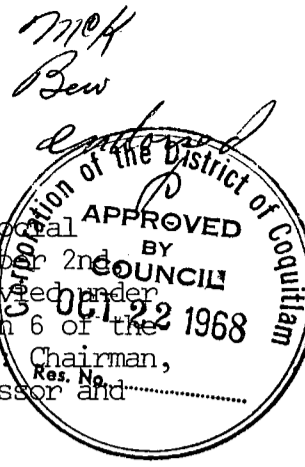




SANITATION COMMITTEE
