I respond to your letter of August 23, 1989 to Ken McLaren. On June 5, 1989, Council passed Resolution No. 853:

"That all plans of Municipal and Public Buildings be referred to the Committee on the Disabled for review and recommendations related to meeting the needs of the handicapped in such Public Buildings."

Council did not accept the idea that a representative of the Committee on the Disabled sit on the Design Committee.

I believe there is some misconception of the role of the Design Committee on the part of the members of the Committee on the Disabled. The Design Committee is made up of professionals in the design field, be they architects, landscape architects, engineers, interior designers or non-architect building designers. Secondly, the Design Committee does not get into the kind of design details which are of interest to the Committee on the Disabled.

My understanding is that Richard White is fully aware of the concerns of the Committee on the Disabled and that plans for any civic buildings are to be referred to that Committee by Council Resolution No. 853. The Provincial Building Code provides for handicapped access requirements which pertain to all buildings to be utilized by the public, whether private or civic in nature.

The Design Committee has had its own concerns with civic buildings. In some cases, they have simply looked at the preliminary concept plans and not seen the working drawings at the building permit review stage. They have also had some concerns with the limited response and follow-up on their suggestions.

In closing, I believe the Committee on the Disabled should really discuss their concerns with the Director of Permits and Licences.

A report on traffic signal needs use compiled by Supervisor of Traffic and Transportation, Tim Murphy, has been accepted and approved by Council.

Invitation will be made to certain individuals and organizations, but it will be advertised and open to all residents of Coquitlam. Policy #1

- The BCCD reaffirms its policy seeking mandatory affirmative action legislation at both the federal and provincial levels towards employment for persons with disabilities.
 - 1.2
- The BCCD will work to ensure prior and ongoing input into all aspects of design, implementation and review of employment related programs involving persons with disabilities.

- The BCCD will promote general skill level advancement for persons with disabilities towards greater economic participation.





Dear Kathryn:

Access to leisure for people with disabilities is often severely limited by lack of consistent, available information about these pursuits. There is a great deal happening in many different locales, but people don't know about it, or know how to access it.

A small group of concerned people is attempting to resolve this problem through the creation of a comprehensive computer database about accessible leisure facilities and activities. "Access to Leisure" has already received strong support from over thirty different organizations. Many were represented at an initial information meeting on May 15th.

The idea has created many more questions than answers. Such issues as funding, physical location, scope, updating, staffing and promotion have all been raised. The recently formed Access to Leisure Steering Committee plans to hire a consultant to provide some of these answers, to determine the project feasibility and to prepare an inital proposal and budget for funding.

No one agency or organization appears to have the budget to provide the required seed funding to get the project underway. But together we could do a great deal! While there will be no guarantees, we are confident that a professional approach from the beginning will result in funding success. That's why we're asking everyone concerned to help out in getting the feasibility study and a professional proposal prepared.

We ask that Coquitlam Parks & Recreation consider a contribution of between \$100 and \$500 to the seed funding of "Access to Leisure". The money will be used to hire the consultant who will do the initial exploratory work. If possible, we'd appreciate your commitment by September 15th so that we can prepare our budget and move the project ahead. We'd also welcome your suggestions of other funding sources.

PROJECT PROPOSAL

Project Title:

"ACCESS TO LEISURE", Information Network

Objective:

To develop a computerized database of leisure-related programs, services and facilities in the lower mainland with a focus on information necessary for successful community integration for persons with a disability.

Rationale:

Research has indicated that "lack of information" is a major perceived barrier to the community recreation participation of persons with a disability (Hutchinson, 1980). The development of a non-threatening, easily accessible information network is seen as a vital component of the community involvement process.

Critical Components:

- development of a centralized library or resource centre wherein information can be transcribed and updated, as required
- application of a universal system of access
 (e.g., touch-tone telephone or information modules in
 key public areas) that would permit widespread access
 to the information network
- 3. information network to include information relative to: physical access requirements; parking facilities and cost; washroom facilities, location and access; cost and discount opportunities; seating allocation and attendant allocation location; reservation requirements; hours of operation; support services available (e.g., volunteers, wheelchair loan, etc.); and other information, as appropriate.
- 4. information focus initially will be on leisure-related programs, services, and facilities in the lower mainland, including: movie theatres; shopping centres; restaurants; recreation centres/facilities (including pools, arenas, parks, beaches, fitness facilities, etc.); theatres; tourist attractions; hotels, motels

and other accomodations; sport, concert, and special event locations and ticket information (including horseracing, football, hockey, etc.); special interest clubs and organizations (e.g., Disabled Independent Gardeners Association, Scuba Diving, Wheelchair Sport and other organizations, etc.); public and private sport and recreation facilities (e.g., golf, racquet sports, fitness, etc.); and other leisure-related information.

"ACCESS TO LEISURE"

What is it?

At present it is an idea conceived by some staff of the British Columbia Rehabilitation Society. The concept is to develop a computerized database of detailed information about leisure facilities which are accessible to people with disabilities on the lower mainland. This information must be kept current, readily available and well-promoted.

Why is it needed?

While a great deal of important work has been done in improving accessibility to housing, transportation and employment, leisure is not often seen as a priority. However, in many instances leisure is a quality of life issue and, for some people with disabilities, is their only significant occupation.

At present it appears that there are several sources of information on accessible facilities. However, none is comprehensive, their reliability varies and some of the data is out-dated.

What kind of support is there for the idea?

More than 30 organizations have been contacted to determine the viability of the idea. Many attended an initial information meeting on May 15, 1989, at G. F. Strong Centre. The support for the idea was overwhelmingly positive. There were many suggestions offered at the meeting. However, there remains more questions than answers and many details yet to be determined before a concrete proposal can be prepared and presented to potential funding sources.

What happens next?

A Steering Committee is being formed. Its initial task will be to engage some professional assistance in defining the concept, working out the details and writing a convincing proposal. It has been proposed that the financing for this initial proposal preparation come from all the interested agencies and organizations, with contributions ranging from \$100 to \$500 each.

FOR FURTHER INFORMATION

Attached is a more complete explanation of the original concept for "Access To Leisure".

4. Business Arising


4.1 Richard White, Director of Permits and Licensing spoke to the Committee about Council Resolution 853. He suggested that the work of checking plans to 3.7 code requirements and recommendations be added to the terms of reference of the tender document.

Impact on budgets to get the 3.7 requirements and recommendations was discussed; as well, Mr. White informed the Committee that not all of 3.7 is required there are recommendations in 3.7 as well.

The library doors were used as an example of meeting 3.7, but not adequately. Council has addressed this and all future public buildings will have automatic doors.

The next municipal building will be the temporary offices for the Planning Department. This building has a ramp, wide doors and handicap accessible washrooms. The committee asked questions re counter height, hardware used for sink, etc. items which would make the washroom accessible and go beyond that user friendly.

Merle Smith responded to Richard White's comments suggesting that a user committee or an architect be paid to review the plans; she had, however, been unable to locate an architect up on 3.7 in Coquitlam.

After discussion, Richard White suggested that consultants for District buildings be told firmly that the District of Coquitlam intends to enforce both the requirements and recommendations of 3.7, and that all of these items should be costed separately so that the District can decide which items it wants to commit itself to.

The Planning Department building will be used as a test case to in-house check plans for 3.7 recommendations and requirements. A plan checker in Richard White's department will go over the plans using 3.7 and cost the recommended items and requirements.

The Committee approved this course of action.

Members of the Committee had some concern about the washrooms for this facility. Mr. White will wait to see how the plan checkers review the accessibility looking at 3.7. It was felt by the Committee that the doors may not be wide enough.

Committee thanked Mr. Elliott for attending our meeting.

4.3 Community Forum

The date and time is secured for 12 p.m. - 3 p.m. on February 10. A facilitator/mc will be needed to keep order, keep things on track, etc.

Suggested that we may need break-out-rooms; Kathryn to look into this.



Discussion ensued regarding Parks and Recreation facility's doors needing to be updated.


