# ITEM 3 - REVISIONS TO AGREEMENT

THAT the Jack Cewe Park Agreement be redrafted by the Municipal Solicitor, Henry Castillou, in consultation with the Jack Cewe Ltd. solicitor, and presented to the Committee for consideration, AND THAT the terms of reference are generally as follows pertaining to the above redraft:

the District of Coquitlam commits to creating a park named the 'Jimmy Christmas Park' on lands which are transferred to the District by dedication or Crown Grant;

the Company will remit the sum of 3.5 cents for every tonne of material removed from leased and owned lands by Jack Cewe Ltd. and its successor companies, if any, to the District of Coquitlam;

the District of Coquitlam will establish a statutory trust fund to receive and hold the remittance from the Company, together with any interest earnings;

the sole permitted use of the trust fund will be to pay for the planning, design, construction and maintenance of the Agreement which may include a Municipal public golf course.
