



502-1 Delegation - Coquitlam Little League - Proposal to Install Corporate Funded Electronic Scoreboard at Blue Mountain

Mr. Michael Waggett, Vice-President of Coquitlam Little League, appeared before the Committee to request approval of a corporate funded electronic scoreboard at Blue Mountain Park.

Mr. Waggett stated no funding was available from the City for a new electronic scoreboard so the Association sought corporate sponsorship for the project. He further stated that Coca-Cola was willing to pay for the capital cost of the scoreboard including all necessary permits and complete

installation. As well, the corporate sponsor has requested that their logo appear on the scoreboards in addition to whatever logo and/or message that the City requested and the name of the Park, and that the park sell the corporation's product at the concession.

Mr. Waggett stated that the scoreboard would be powered independently from the field lights, that the operator box would be located behind home plate and that the proposal included all electrical conduits required for the installation. He added that the scoreboard would be considered a donation to the City and the park and that Coquitlam Little League wants to work with the City in developing private partnerships and improving parks.

The Committee discussed the formation of a policy for corporate sponsorship in public facilities that may include criterea for approval including safety and appearance issues. As well, a Call for Proposals could be drafted that would include all facility and park improvements and, therefore, all beverages that the City sells. The Director of Leisure and Parks Services stated that a draft policy could be available in 4-6 weeks.

The Committee asked that the request of Coquitlam Little League and development of a corporate sponsorship policy be considered concurrently. The electronic scoreboard will ultimately require a Development Variance Permit and approval by Council, and this permit will be brought forward once a policy has been developed for Council consideration.

COUNCIL ACTION:

That Council approve the request from Coquitlam Little League to install a Nevco Electronic Scoreboard at Blue Mountain Park baseball field conditional on:

a) all costs for design, tendering, installation, application and permit fees being borne by Coquitlam Little League;

b) installation details accompanied by stamped engineering drawings and location to be approved by the Director, Leisure & Parks Services; and

c) score clock be available for use of all baseball teams/leagues that are allocated field use at Blue Mountain Park.



> Mr. Wayne Cousins appeared on behalf of his parents who reside at 769 Foster Avenue. He said that the public process with regard to the cemetery has been inadequate and has not provided an opportunity for residents to provide proper input. Mr. Cousins said that there have not been proper studies of the site and requested that Council have detailed social, economic and environmental studies done.

> Ms. Michele Chu, 757 Sprice, said that she had many concerns about the process. She said that the Task Force was not properly set up nor did it adequately represent the persons in the area. Ms. Chu said that area residents do not trust the City to keep its word.

Mr. Wayne Tanaka, 740 Sprice Avenue, said that it doesn't make sense to spend \$2.4 million on a short-term solution at the Robinson Street Cemetery. He said that the expansion could result in traffic congestion and problems. Mr. Tanaka said that the residents want the forested areas to remain as it is. Mr. Tanaka submitted a petition of 130 persons opposing the expansion of the cemetery. Mr. Tanaka said that there are some residents in the area who feel the land is not being used in accordance with the Zoning Bylaw and that they are prepared to take legal action. Mr. Tanaka submitted a brief prepared by Mr. Brian Williams who was unable to attend the meeting.

Ms. H. Twarog, 723 Ebert Avenue, said that expanding the cemetery will destroy the enjoyment that residents currently have as a result of the forested areas. She said that the community does not need any more cement in neighbourhoods.





Colony Farm: Ms. Schade stated that GVRD Parks took title of this park on 1996 December 24 and currently includes one full-time staff person. She stated that the Colony Farm Task Force is evolving into a Park Association and implementing the principles of the Colony Farm Land Use Plan. She further detailed some short-term plans for the park including marsh development, hedge row planting, tree planting and maintenance for wildlife development. Ms. Schade further stated that day park development, trail and bridge maintenance were scheduled for 2002.

Minnekhada and Minnekhada Farm: Ms. Schade stated that a crown grant was received to restore and service the farm site and provide public access to these facilities, although only a portion of the improvements were currently funded and that the GVRD was seeking partnerships for this work. She added that minor building and drainage improvements were being completed now and that equistrian facilities were being considered for the future.

Mr. P. Skydt provided information on the GVRD Greenways Plan objectives and outlined the planning timeframe for the Greenways Plan and a preliminary list of the participating agencies.





Jones, Director of the West Coast School of Mountain Biking, provided a brief overview of the sport of mountain biking and the involvement of students and residents generally in the province of British Columbia and the City of Coquitlam. Ms. Jones outlined the possible construction approach to the trail system and stated that there was no need for additional facilities or lights with the bike trail proposal.

Mr. Tvergyak stated that the proposed bike trail would be designed by students in consultation with City staff and with due consideration to the liability concerns of the City.

Ms. Jones stated that the trail could be designed at an easier to intermediate level with all "obstacles" inside the loop or have varying difficulties of "obstacles" constructed as part of the trail itself. She added that the West Coast School of Mountain Biking used portable obstacles and, from her perspective, the first approach was preferred. She further stated that the level of difficulty would not be challenging enough for elite competitions but rather for recreational use.
