# Subject: Proposed Referendum for Major Roads, 1977

A meeting of Council, sitting as a "Committee of the Whole", convened in the Council Chambers of the Municipal Hall, 1111 Brunette Avenue, Coquitlam, B. C. on Thursday, September 8th, 1977 at 7:00 p.m. with the following persons in attendance:

Council had been presented with a report from the Engineering Department with respect to a proposed referendum for major roads, a copy of which is attached hereto and forms a part of these minutes.

Ald. Parks advised the Committee that the Public Works Committee of Council had considered the report and proposal at their meeting on Wednesday, September 7th, 1977 and would be recommending proceeding with the referendum for Como Lake Avenue, Brunette Avenue and North Road. He further advised that the Committee were not too enthusiastic about proceeding with the RidgewayyMall concept at this point as there was still the matter of method of financing. Ald. Parks did advise that the Committee were in favour of the concept of the Ridgeway Mall proposal but felt possibly it should be a separate referendum.

Ald. Garrison enquired of the Engineer as to what contacts had been made with New Westminster and Burnaby with respect to the North Road widening and was advised that one meeting had been held with representatives from Coquitlam, Burnaby, New Westminster and the Department of Highways, however after this meeting, New Westminster's representative advised that he would have to give more consideration to the proposal even though all the other representatives had expressed enthusiastic support of the proposed project.

Mr. Hockey further advised that Burnaby had requested Coquitlam to <u>makerprovision</u> for its share of the cost of design of a four lane bridge with such a design being necessary before actual costs could be determined for the peplacement of the bridge.

Mayor Tonn stated that in his opinion the widening of North Road should be covered by short term borrowing as construction in this area has to be expedited.

The Mayor also advised the meeting that prior to making any commitment, Council should be aware of the financial impact with respect to the cost of last years work and the cost of short term borrowing and the implacations that this would have on the limits of municipal debt. > Mr. Hockey stated that the amended budget should contain a provision to cover design costs for the four lane bridge on North Road in order that this municipality together with Burnaby could ascertain exact costs.

MOVED BY ALD. PARKS SECONDED BY ALD. GARRISON:

That Council not proceed with placing on the referendum the widening of North Road between the Trans-Canada Highway south to the municipal boundary with New Westminster and further, that the Municipal Engineer be authorized to make provision in the amended budget for design funds for the bridge as required in this area.

#### CARRIED UNANIMOUSLY

Discussion then took place with respect to Ridgeway Mall and the priority which should be given to this project.

Some members of Council felt that discussions should be held with property owners with respect to methods of financing, such as on a local improvement basis while other members of Council felt that even if anmethod of sharing of costs can not be worked out, the project should proceed as this is to be theffocal point of commercial development in this area.

In answer to a question from a member of Council Mr. Hockey advised that the reconstruction of Brunette Avenue could be done in one year, however, should Council so desire, the referendum work could be spread out over a five year construction program.

A great deal of discussion took place with respect to the inclusion of Como Lake Avenue in the referendum, with Council being advised that Como Lake Avenue has now reached capacity and widening is essential if traffic is to continue to move without encountering delays. Mr. Duguid advised that should Council consider only a portion of the street for widening, the western end is the most important.as this is where the greatest bottleneck is occurring.

Ald. Garrison felt that the referendum should be split into two to allow the electorate to better voice their opinions.

Discussion took place on this aspect together with the possibility of the failure of the referendum on the Como Lake reconstruction as well as the Brunette Avenue reconstruction were the referendum to be split into two.

Council also gave a great deal of thought and discussion to the matter of only doigg a portion of Como Lake Avenue at this time with various sections being considered.

Council at this point in the discussions requested that the Municipal Manager bring forward a report on the cost impact which could be expected if the referendum were approved. When preparing the report, he should be taking into account that the funds for the referendum work were to be borrowed over a twenty year repayment period with the work being done in a five year period with the expenditures in each of the five years to be of an equal amount.

That the issue of the proposed referendum be tabled until Monday, September 12th, 1977 at 4:00 p.m.

Klassen The Council, at the Committee of the Whole meeting of September 8th, 1977 dealing with the subject of a proposed referendum for major roads, 1977, had tabled a resolution with respect to the program to be included in the proposed referendum. The purpose of tabling the motion on September 8th, 1977 had been to allow members of Council to consider the matter for some days and also to give them an opportunity to speak to ratepayers and

others with respect to the widening and improvement of Como Lake Avenue. Members of Council reported at the beginning of the meeting on contacts

that they had had over the weekend with respect to the widening of Como Lake Avenue.

The Mayor, following receipt of reports from members of Council, then proposed a program for referendum which would exclude the widening and improvement of Como Lake Avenue east of Clarke Road. This program included:

1. Brunette Avenue - from Woolridge Street to Laurentian Crescent

2. Ridgeway Mall - from Marmont Street to Nelson Street

3. Como Lake Avenue - from North Road to Clarke Road

4. Clarke Road - from Como Lake Avenue to Ingersoll Avenue

The Mayor stated that the estimated cost of such referendum would be \$2,615,000.

MOVED BY ALD. ROBINSON SECONDED BY ALD. SEKORA:

That the resolution tabled at the meeting of September 8th, 1977 with respect to the proposed referendum for road improvements be lifted from the table.

Following my perusal of the Minutes initiated from your meeting of September 8, 1977 which dealt with the above-noted subject matter, I noted the request for certain financial information. This request was for "...a report from the Treasurer on the cost impact which could be expected if the referendum were approved." The budgetary provisions relate reasonably to the estimated cost of work. Accordingly in order to respond to Council's request, I have simply addressed myself to the contents and financial implications set out in the 1977 - 1981 Capital Expenditure Program By-law No. 740, 1977 and the 1977 Annual Budget By-law No. 738, 1977. (Best information available)

1. 1977 - 1981 Capital Expenditure Program By-law No. 740, 1977

- a) Present Assumptions
  - Basis of establishing assessments remains unchanged i.e. 50% of Actual Value, 10% and 5% limits removed on all but residential and farm properties
    - (Note for fiscal year 1978 the assessed values will be a percentage of actual value by class subject to transitional formula)
  - Programs contained therein represents Council's priorities
  - Cost estimates utilized are reasonably representative and adequate
  - No financial grants available to offset any portion of anticipated costs
- b) Observations
  - Projected debt impact will rise from a present level of 1.4 million dollars to 5.3 million dollars by 1981 averaging approximately 1 million dollars per year increase.
  - Projected debt charges will represent an increasing proportion of the projected -

Comments:

By relating the aforesaid statistics to certain accepted guidelines employed by borrowers to evaluate a municipality's credit, the prima facie evidence indicates that one should feel apprehensive about our immediate capacity to carry this debt without undermining our financial viability. However such guidelines are not definitive. In the final analysis, a municipality's debt level will depend to a considerable extent on Council's attitude towards borrowing, the Council's determination to acquire amenities without delay, and its willingness to accept the cost of debenture financing.

- 2. Other Areas Observed
  - a) Determination of Borrowing Power per Section 249 of the Municipal Act. As at December 31, 1976 the District's gross borrowing power stood at \$39,524,865, its present authorized debt at \$21,517,370, and its unused borrowing power at \$19,666,492. How valid this information is for determining our debt carrying capability is questionable because of its excessive results.
  - b) Short Term Borrowing Section 260 of the Municipal Act.

The aggregate Short Term debt for the District cannot exceed approximately 1.4 million dollars (population of 55,464 times 25 dollars) according to the laid down formula

At this time our use of short term capital borrowings amounts to the following:

As is obvious, there is insufficient scope within our short-term borrowing capabilities to absorb all the proposed projects. Because this form of borrowing does not require the assent of the electors it is my opinion that the District should assess its priorities so that it can take maximum advantage of the greater ease of borrowing afforded by this section e.g. retain for - "emergency" type projects that could have

greater difficulty obtaining electors' approvals. The uncommitted shortterm borrowing allowance approximates \$500,000.

In conclusion, I must stress again that my comments are based on a "rough" five year Capital Expenditure Programme, which has yet been evaluated critically for formal acceptance.





# THE PROPOSED 1977 ASSESSMENT BASE ALTERNATIVES

Mr. Wyatt reviewed with Council the history of assessments since 1953 leading up the threat new assessment legislation adopted by the Provincial Government.

Mr. Wyatt also presented to the Committee a copy of the Orderin-Council pursuant to Sections 24(7) and 24(8) which sets out the percentages of actual value at which each class of property defined is to be assessed for 1978. A copy of that Order-in-Council is attached hereto and forms a part of these Minutes.

Mr. Wyatt also presented to Members of Council some examples of phase-in calculation as well as a copy of the proposed 1978 Assessment Notice, copies of which are attached hereto and form a part of these Minutes.

In answer to a question from Mayor Tonn, Mr. Wyatt explained that the Assessment Authority are using July 1st, 1976 as the datum line to set actual assessment values and will be continually updating the datum line for each successive year, however, the datum line will most likely always be one year behind actual values.

Mr. LeClair enquired as to whether the Provincial Assessment Authority will be providing annual studies to municipalities in order to allow them to give informed consideration to possible election of one of the other options available with respect to taxation.

Mr. Wyatt advised that from October 31st onwards, a comprehensive information program will be undertaken to advise the general public of the change in assessment legislation,

this being carried out in the newspaper, on radio and on television. Further, he advised that the Assessment Notices will be mailed one month early and a brochure will be enclosed with the Notices to further explain the changes in legislation.

Mr. Wyatt also advised Council that the Provincial Assessment Authority is also considering the placing of staff in municipal halls in order that explanations of the changes in assessments can be readily given to persons seeking information. Mr. Wyatt further advised that his office will be accepting invitations from ratepayers groups to speak on the changes in legislation, and it is hoped with this fairly extensive public relations program that the public can at least be informed as to the meaning of the new method of assessing properties.

## CAPITAL EXPENDITURE PROGRAMME

The Committee proceeded to study the 1977 Capital Expenditure Programme in order to better understand the document and come to some conclusions with respect to how the programme should be established for future years.

The Municipal Manager explained to Council that with the exception of the year 1977, the present Capital Works Budget is largely a staff effort to indicate projects which they would see Council considering in future years.

Mr. Buchanan also explained to the meeting that the new development cost charges under Section 702(c) of the Municipal Act will have to bear some relationship to the Capital Expenditure Program and unless the development cost charges can be substantiated by the Capital Works Budget, such charges may not be approved by Victoria. He also went on to advise that major financial houses are looking for such documents when large borrowings are being sought.

The Mayor advised Council that he felt the second and third year of a Capital Expenditure Programme should be much more meaningful than what they presently seem to be. He felt that Council should be more closely studying at least the first three years of a Capital Expenditure Programme.

Some departments of the Municipality were instructed by Council to alter certain items within the Capital Works Budget in order that they be reflected in later years as Council has not yet had a chance to consider a great many of the proposed projects.
