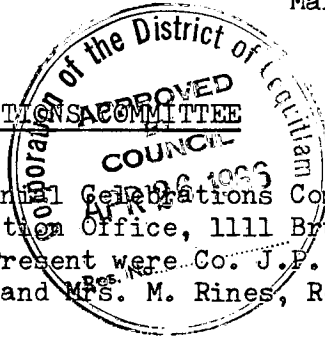

Present were Co. J.P. Clarke, Chairman; Mrs. S. Currie, J. Robinson, R. Mitchuk and Mrs. M. Rines, Recreation Secretary.



Vice Chairman

The Chairman recommended Mrs. Currie as Vice Chairman, seconded by R. Mitchuk and agreed.

The meeting suggested that the Programme Committee obtain costs on both the purchase of banners and the renting of same from Vancouver. The Chairman agreed to bring before Council the matter of new "District of Coquitlam" signs, with a Centennial motif, at entrances to the Municipality.

Thompson and Mrs. G. Richardson are interested and would reactivate the Coquitlam Drama Club. Inter-denominational Church Service - to be held on the Sunday of the main week of celebrations.

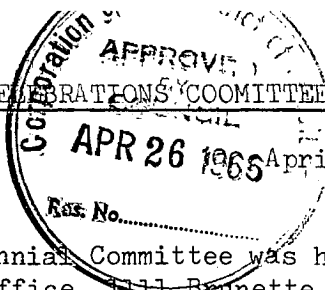
## Paper Place Mats

Building Committee Submission

Mr. Russcher of Russcher, Hansen architectural firm tabled the drawings for the District of Coquitlam's Centennial Social Recreation Centre. Building Committee Chairman Mr. Ken Webber congratulated Mr. Russcher on the excellent design; however, the meeting tacitly agreed that the budget given the architect was causing him to have to design a building that was not really meeting the needs of the community.

Building Committee Meeting

Mrs. Currie requested the Building Committee to meet within the next two weeks to review the plans as presented in light of the discussion that took place and that particular emphasis should be given to;

1. The size of the crush area,
2. the traffic circulation,
3. the existing service areas,
4. to what extent are the committee rooms convertible to other activities such as Arts and Crafts,
5. storage facilities,
6. the orientation of the kitchen.

Moved by R. Mitchuk, seconded by R. Boileau that the proposal be referred back to the building Committee for their immediate study and action.

Vocational School

Co. Clarke requested the Building Committee to take into consideration the exterior design of the Vocational School, as it will be the largest building in the Civic Centre Complex.

The meeting was advised by Mr. Russcher, building architect, that the site given for the building is regrettably in a hollow and will require considerable sand fill before the building can be constructed. Co. Clarke informed the meeting that the Board of Works could very easily look after the preparation of this site.

Centennial Caravan

Mrs. Currie was named co-ordinator of this programme and the meeting was advised by Mr. Mitchuk that the Centennial Caravan will be advertised on the Shopping Centre marquee and by the remote radio station that will be sited on the parking lot during the visit of the Centennial Caravan.

This matter is to be placed on the agenda of the next Celebration Sub-Committee meeting.

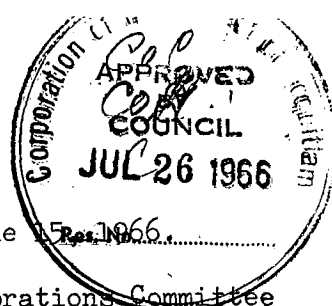

DISTRICT OF COQUITLAM CENTENNIAL CELEBRATIONS COMMITTEE



June 15, 1966.

A general meeting of the District of Coquitlam Centennial Celebrations Committee was held in the Council Chambers of the Municipal Hall, 1111 Brunette Avenue, on Wednesday, June 15<sup>th</sup>, 1966, at 8:00 p.m.

Present: Co. J. P. Clarke, Chairman; Mrs. S. Currie, Mrs. J. Schwab, R. B. Stibbs, K. Webber, T. Killingsworth, R. J. Mitchuk, Mrs. M. Rines, D. L. Cunnings, and, during the building discussion, architects K. Russcher and A. K. Hanson.

Recommendations of the Building Sub-Committee

Chairman of the Building Sub-Committee, Mr. K. Webber, outlined to the meeting the following points and recommendations:

1. The Committee had agreed that this project must be of permanent nature, to be a worthy Centennial project, and one which would fill a community need.
2. Council had not yet decided on locations for various buildings in the Civic Centre complex; therefore, the building site had not been finalized.
3. First plans had been revised to add space and the Committee still hoped that it would be possible to put even a part-basement under the building; they had now accepted the revised plan with the proviso that some alterations may be made, and thus, the sub-committee was recommending that the total committee approve same, which would mean approaching Council for an additional \$12,000.00 for the extra 670 square feet as shown in the revised plan.

During the discussion on the recommendations, it was suggested that the Centennial Building architects be in liaison with the Municipal Hall architects, and Mr. Stibbs also suggested that possibly the Centennial School architects should be contacted to make sure of overall co-ordination.

The meeting agreed to give the Building Sub-Committee authority to proceed with drawings and specifications, subject to the approval of the site location by the co-ordinating architects and also subject to the approval of the project by the Federal Centennial Committee.

Motion Moved by K. Webber, seconded by T. Killingsworth  
That the report of the Building Sub-Committee be accepted.

Carried.

Minutes Moved by K. Webber, seconded by T. Killingsworth  
That the minutes of the general meeting of April 14<sup>th</sup> and committee minutes of April 21<sup>st</sup> and April 28<sup>th</sup> be accepted as circulated.

Carried.

Budget Mr. Mitchuk advised that a budget would be brought down as soon as possible.

The meeting requested that D. Cunnings ensure proper distribution of Centennial calendars and medallions.

Motion Moved by K. Webber, seconded by R. B. Stibbs  
That Mr. Mitchuk be empowered to look into the matter of medallions and celebrations and bring back a report to the next meeting; and that he be directed to present a budget to the next meeting.

That, because P. J. Filiatrault had declined an appointment to this Committee because of pressure of business, Mr. D. Cunnings be authorized to approach Mr. Leo Comeau.

Centennial Signs

Moved by Mrs. Currie, seconded by R. Stibbs

That a letter be sent to the Provincial Committee in Victoria, asking what signs might be available to Municipalities.

Carried.

Centennial Book Cover

Mr. Stibbs reported that schools had been notified of the contest and results would be forwarded to the Committee.

Bronze Plaque

The meeting requested that a bronze plaque for the Centennial tree be included in the budget.

Boy Scout Committee Meeting

It was recommended that the Programme Committee meet with the Boy Scout Committee for an evaluation of this year's "Steak-Out" and to formulate plans for next year.

Babe Ruth Tournament

A Centennial Babe Ruth Baseball Tournament would be held in Blue Mountain Park on July 1st week-end and members were requested to attend, if possible.

Historical Society

Moved by Mrs. Currie, seconded by K. Webber

That the Programme sub-Committee contact the Historical Society with a view to co-operating in the opening of the railway station.

Carried.

Outstanding Accounts

Moved by R. Mitchuk, seconded by R. B. Stibbs

That outstanding accounts be paid.

Carried.

Centennial Lacrosse Game

Moved by R. B. Stibbs, seconded by T. Killingsworth

That letters be written to the Salmonbellies, Adanacs and the New Westminster Centennial Committee, with a view to having one lacrosse game played for a "Centennial Cup", as an annual event, with the cup to be provided by the two Centennial Committees.

Mr. Russcher pointed out that there may be a parking problem but that Council was considering the acquisition of two lots to solve the problem; however, the Council was also considering a change in location of the new Municipal Hall which could affect the site of the Centennial Building as well.

That we recommend to the Centennial Celebrations Committee that Council be approached for an additional \$12,000.00 for the extra 670 square feet as shown in the revised plans.

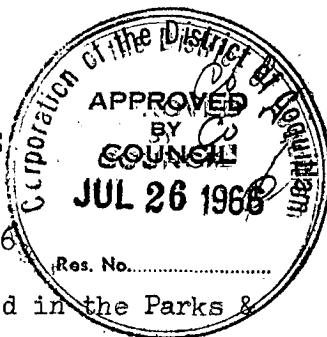

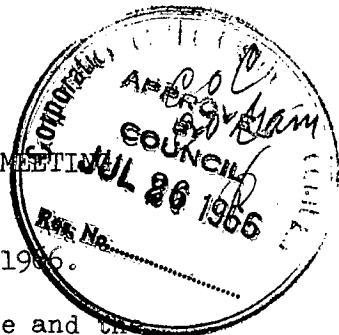

July 6, 1966.

A special meeting of the District of Coquitlam May Day Committee and the Centennial Celebrations Sub-Committee was held in the Recreation Department Office on Wednesday, July 6<sup>th</sup>, 1966, at 8:00 p.m.

Purpose - Mrs. Currie stated that the purpose of this joint meeting was to discuss the disposition of the funds held by the May Day Committee, in light of the Centennial Celebrations planned for the District of Coquitlam.

May Day Secretary-Treasurer's Report

Mrs. Alice Gamache, Secretary-Treasurer, reported that her records showed a bank balance of \$1,126.18 in the May Day savings account; and \$323.29 in a current account. Total May Day bank balance as of 1962: \$1,449.47.

1963 May Day Expenditures: On July 5<sup>th</sup>, 1963, a \$100.00 expenditure was approved to assist in the opening of the District of Coquitlam Sports Centre.

1964 - On March 11<sup>th</sup>, 1964, a \$25.00 grant was approved to the Blue Mountain Red Wing Soccer Club.

May Day Committee Bank - the meeting was advised that the Royal Bank, North Road & Lougheed, is the official bank of the May Day Committee.

In light of the quiescent state of the May Day Committee, the May Day members present were asked if they would entertain transferring all or a portion of the May Day account to the District of Coquitlam's Centennial Celebrations Committee, for celebrations purpose.

Motion

Moved by Mr. Gueho, seconded by Mrs. Alice Gamache  
That all remaining May Day funds be transferred to the District of Coquitlam's Centennial Committee, on the proviso that a sum of \$500.00 be extended for the sole purpose of developing a permanent full display in conjunction with the Parks Department Centennial Garden, to commemorate the District of Coquitlam's May Days; and that this portion of the garden be marked by a bronze plaque.

Transfer of May Day Accounts

Moved by Mr. Frank Crowley, seconded by Mrs. Shirley Koette  
That Mrs. Gamache be instructed to issue a cheque to the District of Coquitlam Centennial Celebrations Committee, in the amount of the remaining funds and, further, that all May Day accounts be officially closed.

Moved by Mr. Manny Gueho, seconded by Mr. Frank Crawley  
That Mrs. Alice Gamache be authorized to turn over all May Day documents in her possession to Mr. D. Cummings, of the Coquitlam Recreation Department, and, further, that Mr. Cummings search out all former May Day documents and films held in the Municipal Hall vault and arrange to officially transfer these documents to the District's Historical Society.

Special Centennial-May Day Ceremony

The following recommendations were made to the District's Centennial Celebrations Sub-committee:

1. To arrange an actual Maypole Dance
2. To contact all former District of Coquitlam May Queens and invite them to attend this special Centennial ceremony at their own expense.
