

515-1 2000 Gender Equity Data Collection Report

COUNCIL ACTION

That Council submit the 2000 Gender Equity Report to the Human Rights

Commission.

The Gender Equity Coordinator presented the 2000 Gender Equity Report. The Report contains eight statistical reports that reflect the sport and physical activity measurements as required by Human Rights Special Program. These eight statistical reports summarize the data collected in 2000 for gender, age, and subsidization analysis purposes. In addition to the statistical reports, there are participation rate comparison reports for 1999 and 2000. These comparison reports are used to measure the increase in young female participation for 2000.

The analysis of the young female participation rates show an increase in each of the four areas of service delivery for sport and physical activities that are reported. There was a 14.3% increase in registered program participation with the majority of the increase attributed to increased opportunities for children and preschoolers to participate in sport activities. There was a 20.2% increase in the participation of females engaged in community sports through the rental of City subsidized facilities which occurred mainly in the reallocation of City sportfields to female sport organizations. A 27.7% increase in admissions to pools, arenas and gymnasiums was recorded but much of the increase will be due to increased accuracy in data collection methodology. The analysis of the admissions data for 2000 – 2001 will reflect a truer picture of the level of increase in participation. There was a 7.9% increase in participation in casual use of outdoor facilities that could be due to better weather in the summer months of 2000.

Committee members are encouraged to review the completed report and refer any questions they may have regarding the statistics or the interpretation of the statistics to the Gender Equity Coordinator.

### 515-1 2000 Program (Level One) Participation Rates

The preliminary results show a 10% increase in young female participation rates with preschool programming showing the most distinct increases. ### 515-1 Tax Exemption Report

Gender Equity Committee received the report from the Collections and Cash Manager regarding the City of Coquitlam process for tax exemption requests. Discussion focused on what changes would be in effect at the end of the five year Gender Equity Agreement to ensure that the systemic



barrier to non-profit predominately female sport groups who do not have access to City facilities would be removed. Concerns were expressed regarding how recipients of the Special Fund would fare once the term of the grant have expired.

The Gender Equity Committee directed staff to prepare correspondence to the Omega Gymnastic Academy encouraging them to apply for a tax exemption as outlined in the Collections and Cash Manager's report.

### 515-2 Policy Revisions for Leisure & Parks Services Report

The Committee received the report on the status of the Policy revisions and suggested that Leisure & Parks Services staff ensure that the policy statements contain action-oriented language in order to have substance in ensuring systemic barriers are removed.

### 515-3 2001 Goals & Objectives – Facility Strategies

The Committee received the report on 2001 action plans related to gender equity. The Committee discussed the importance of marketing the opportunities for females in a variety of ways to ensure Leisure & Parks Services is reaching the entire community. It was suggested to include the private schools in the community in any fax/mail outs which might traditionally only go to public schools. P. Cooper offered to speak at a Leisure and Parks Marketing Committee meeting regarding effective media releases. It was also suggested to use an electronic subscription method once Smart Communities technology is in place.

### 515-4 Believe In Yourself – A Conference For Girls

The Committee received the report on the Conference for Girls and endorsed the concept of this type of promotion for girls to be involved in physical activity. The Committee would hope that more conferences would be planned based on the success of this one. It was also suggested that Leisure & Parks Services staff follow up with programming for girls in the areas of Yoga and Tai Chi given the interest from registrants.

The Committee received the report on the new girls sport programs offered in co-sponsorship with Leisure & Parks Services.
