Of course, the Municipality could purchase whatever bonds it wishes, regardless of the decision of your Council, but as I already stated, you would have previous notice of such purchases."

The above proposal has been accepted by the Mayor and Council of the City of Port Coquitlam and as the same was agreed to by you I would suggest that you kindly have same formally accepted and write the Mayor and Council of the City of Port Coquitlam that this has been done, thereby concluding the matter.

I am instructed to notify you that as soon as the City of Port Coquitlam received acknowledgment to this effect, interest monies, which have been placed in a trust account, will be transferred to your Municipality, forthwith.
