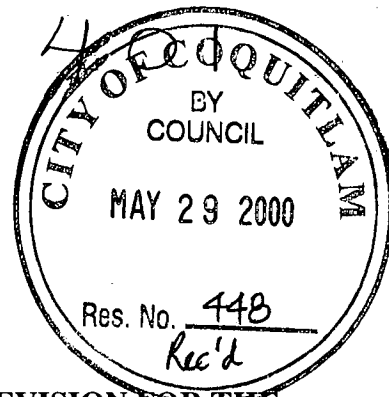

The first sitting of the Court of Revision to hear complaints against the 2000 Frontage and Parcel Tax Assessment Roll was held at 4:00 pm on Wednesday, April 5, 2000, in the City Council Chambers, 3000 Guildford Way, Coquitlam, B. C.
