COMMITTEE OF THE WHOLE

REPORT OF MUNICIPAL SOLICITOR -GLEN ELEMENTARY SCHOOL ADDITIONS

The Municipal Solicitor presented to Council, a letter dated March 23, 1988 from the law firm of Doust and Smith, wherein a proposal was made to pay \$77,931.60, the amount of the Development Cost Charges, into a trust account pending a resolution of the dispute by the Court and that a building permit be issued immediately.
