Ms. Silbernagel stated that Port Coquitlam Mental Health covers all of School District No. 43 with the exception of a small area in south Coquitlam, known as the Maillardville which is covered by the New Westminster Mental Health.

It was reported that Act ll is no longer treating the sexual abused child after a time of 3 months and that PoCo Mental Health will pick that job up.

Ms. Silbernagel spoke about the day to day occurrence between Mental Health and Act ll. She felt that only $80 \%$ of the cases were being reported or referred and the other cases were being lost between the two resources.

Wyne Mudge - Coquitlam S.H.A.R.E. Society
At the last meeting Coquitlam S.H.A.R.E. Society were considering short and long term goals. Some of the those are the consolidated, expansion of existing programming.

Thrift Store - How can it be improved?

Food Bank - (an evaluation) what type of people are we serving? What funding do we need?
Are donations sufficient?
At Christmas time we had 1205 Hampers which served 1480 Children and 1900 Adults.

Recyling is cost effective as it saves the Municipalities and Cities the dumping fee.

The society has started to acquire three homes each with two beds as receiving and assessment houses run by the Horizon Treatment Centres.

School District No. 43
S.H.A.R.E. recently received a letter stating effective April lst that there will be joint decisions made by Ministry of Social Service and Housing and the Ministry of Health regarding management of funding and responsibilities, primarily directed at the mentally ill clients. The level of funding will not be effected by this transfer.

John Maddalozzo suggested that in the coming months the committee should seek out some people who would be able to give the committee information, a suggestion was to contact Christine Klien, District Supervisor, Ministry of Health.
