Report from Community Policing Committee

The Committee received a verbal report from Mr. Cornford on the Community Policing Committee Minutes of 1998 January 13. Arising from these minutes

"The Committee recommends that Council request the FCM lobby the Federal Minister of Justice to pass an Order In Council to clearly make the possession, sale and use of all types of pepper spray and similar products a prohibited weapon."

<u>Report from Fire Department</u>

The Fire Chief expressed an interest in utilizing the Community Police Stations by his Fire Prevention Inspectors on a trial basis to meet the public and distribute fire prevention and public education materials.

The Fire Chief reported that his department had initiated a year round safety awareness program with the Westwood Plateau Golf Club staff. In addition, the Fire Chief stated that the current arterial road access to Westwood Plateau locations continues to present service delivery challenges for his department.

4 <u>Community Police Stations</u>

Cst. Blais reported that the Community Police Stations are very successful. In one year the volunteer base increased from 42 to over 200. The telephone and counter contacts with the public have increased. The new Asian community awareness program was working and that other ethnic groups were making enquiries. A new City Watch program has been started and shows promise, and that other crime prevention initiatives were under consideration.

5 <u>Crime Free Multi-Housing Program</u>

Cst. Blais reported that the Crime Free Multi-Housing program has proven to be successful elsewhere. It involves a significant endeavour requiring the commitment of staff and the securing of support resources. The program involves continuous liaison with landlords and tenants in order to introduce proper crime preventive measures and maintain their interest.

Cst. Blais stated that the RCMP Detachment are preparing to introduce the Crime Free Multi-Housing program on a gradual basis through the Community Police Stations.

ITEM IV - OTHER BUSINESS

1 <u>Police Helicopter Service</u>

Inspector Moulton presented to the Committee a copy of the "First Year Evaluation Report" prepared by the Calgary Police Service regarding their use of a helicopter to respond to requests for assistance.

The Report summaries their first year of operation and concludes that the helicopter service, "... enjoyed tremendous success."

Inspector Moulton stated that a similar helicopter service for Greater Vancouver would require the use of two helicopters. The capital cost of the helicopters would be the responsibility of a Society with the operating costs apportioned to the participating jurisdictions. The annual operating cost for both the Cities of Coquitlam and Port Coquitlam would approximate \$100,000.

Inspector Moulton stated that the Detachment would be forwarding a proposal to obtain an indication of interest from Council in pursuing a partnership arrangement in the operation of a police helicopter service. Tuesday, January 27, 1998 - Page 4 Public Safety Committee - 7:30 p.m.

1. Appointment of Deputy Chair

The Chair appointed Mr. N. Shivji to be Deputy Chair for 1998.

2. Report from Community Policing Citizen Advisory Committee

Mr. T. Cornford reported that the Community Policing Citizen Advisory Committee would recommend to City Council that its name be changed to the "Citizen Advisory Committee on Policing" after review of its Terms of Reference and mandate. He reported that other issues addressed were the Helicopter Service, Consolidated Dispatch and Pay Parking.

Mr. Cornford stated that the issues of pepper spray and vandalism were also discussed by the Committee and may be brought forward for Council consideration.

The Committee discussed the use of pepper spray and its implications for law enforcement staff and personal safety.

The Committee recommends:

COUNCIL ACTION:

That Council request that the Federation of Canadian Municipalities lobby the Federal Minister of Justice to pass an Order In Council to clearly make the use of all types of pepper spray and similar products in a criminal offense a prohibited weapon.

Mr. Cornford stated that the recommendations for substantive changes to the Community Policing Citizen Advisory Committee would be forwarded to the City Councils of Coquitlam and Port Coquitlam for consideration of approval. Minutes of Public Safety Committee Meeting 1998 March 31

3. Report from Community Policing Stations

Sgt. McCrindle stated that the establishment of the Burquitlam Community Policing Station remains a high priority and suggested that investigation of a partnership with the City of Burnaby may generate cost-savings and benefits for both municipalities.

Sgt. McCrindle further stated that "problem-oriented" constables are being used at the Ridgeway Community Policing Station and that Auxiliary Constables are further increasing the police presence in this area. He added that extending the hours of operation of the station would be examined in order to increase this presence.

Sgt. McCrindle stated that the "Take Back our Streets" program would be extended to the Burquitlam area. He added that the RCMP had allowed one Constable for all rural areas of the community and that contact will be made with the various Ratepayers' Associations from Coquitlam neighbourhoods.

Mr. Cornford stated that he attended a Speed Watch Conference by ICBC reported that the use of photo radar had decreased fatalities by 14% and injuries by 10% since its implementation.

ITEM 11 - BUSINESS ARISING FROM THE MINUTES

1 <u>Coquitlam/Port Coquitlam Community Policing Committee</u>

The draft of the Policy and Procedures for the Coquitlam/Port Coquitlam Citizen's Advisory Committee on Policing (currently Coquitlam/Port Coquitlam Community Policing Committee) was discussed. Mr. T. Cornford provided a brief account on the formation, growth and purpose of the Commmittee. There were questions and discussions arising from the draft regarding the selection of the citizen and community group representatives to the Committee, the current and proposed role and accountability of the Committee and a need to better define the relationship between this Committee and the Public Safety Committee. ITEM 111 - NEW BUSINESS

Overview of E-COMM/Fire Dispatch Issues

The Fire Chief stated that it was too early to report on E-COMM/Fire Dispatch. Reports were to be prepared and further discussions were required before he could present an overview for the Committee.

The Fire Chief did report on several other matters. These included meetings with the Ministry of Transportation and Highways on providing an improved water supply system to Port Mann bridge and on the location of turn arounds for emergency vehicles on the reconstructed portion of the Trans Canada Highway, meetings with the Trans Mountain Pipeline Company on developing fire safety programs related to their pipeline, and the Ministry of Indian Affairs on upgrading fire protection for the Kwayhquitlam Indian Reserve on Colony Farm.

In addition the Fire Chief reported that the Fire/Rescue Boat would soon be operational with a well trained crew, 32 fire officers were now instructed in the new BC Standard Incident Command and Management System, and that fire safety programs for major residential complexes had been started and were being expanded with the cooperation of the facility managers.

2 Report from Coquitlam/Port Coquitlam Community Policing Committee

Mr. T. Cornford reported on several issues. These included the Pitt River Board Club request for community/police assistance in reducing theft and vandalism, the Burquitlam Community Association appeal for a community police station and police presence in their area, a program to reduce speeding around schools, and that a review of all recommendations regarding the Policies and Procedures for the Citizen's Advisory Committee on Policing was scheduled for their next meeting. 1998 May 26 - Page 3 Public Safety Committee

3 <u>Report from the Community Police Stations</u>

Sgt. McCrindle reported that a provincial study was underway on the future role of auxiliaries and meanwhile their "uniform duties" in Coquitlam had been suspended. He reported also that ICBC had provided \$24,000 to purchase bikes and equipment to target auto thefts and related crimes, a RAVE party was scheduled for a facility within Coquitlam in late June and early July; cheap drink nights continue to be a significant draw on police resources, and that software was being developed to assist in tracking auto theft and recovery locations.
