#### 1975 LOCAL IMPROVEMENT COURT OF REVISION

#### MINUTES

The first sitting of the Court of Revision to hear complaints against the 1975 Local Improvement Assessment Roll was held at 7:00 p.m., Thursday May 8th, 1975 in the Municipal Council Chambers, 1111 Brunette Avenue, Coquitlam, B.C.

Mr. Protheroe explained that the Assessor Appeals originated from a letter of inquiry by Mr. Ralph Greenwood of 810 St. Lawrence Street relative to the frontage tax imposed by By-Law #173. # DISTRICT OF COQUITLAM BUSINESS TAX BYLAW NUMBER 2029, 1971

## LOCAL COURT OF REVISION

A sitting of the Local Court of Revision to hear complaints against the 1975 Business Tax Assessment Roll for the District of Coquitlam was held on Wednesday, November 12th, 1975 at 7:00 P.M. in the Municipal Council Chambers, 1111 Brunette Avenue, Coquitlam, B.C.

MEMBERS PRESENT: ALD. C.J. FILIATRAULT - CHAIRMAN

ALD. L. GARRISON and ALD. D. HOWARTH

Representing the Municipality: T.J. PROTHEROE, DEPUTY AREA ASSESSOR, B.C. ASSESSMENT AUTHORITY

Mrs. S. Easton of the B.C. Assessment Authority acted as Secretary.

Mr. Protheroe in his opening remarks explained to the Court of Revision, that Mr. A. R. C. Wyatt, Area Assessor with the B.C.Assessment Authority had been appointed by the District of Coquitlam by Council resolution # 1488 (1975) as Assessor for the purposes of the 1975 Business Tax Assessment Roll. Mr. Protheroe further explained that he was before this sitting of the Court of Revision acting for Mr. Wyatt, and that all the statutory requirements of the Municipal Act and the District of Coquitlam Business Tax By-law #2029 had been complide with in regard to the compilation of the 1975 Business Tax Assessment Roll.

APPEAL #1 - Steele, Gerry Account #000215-000 CREATIVE STRETCH FABRICS 221 Blue Mountain Street Coquit1am, B.C.

The appellant did not appear. The letter of appeal was read to the Court.

At this time, the Chairman of the Court of Revision recognized that Mr. Steele (Appellant #1) had now arrived and explained to Mr. Steele that as he was not present at the scheduled time for the hearing of his appeal, that the Court had proceeded exparte and had reached a decision. The Court then allowed Mr. Steele to address them with regard to his appeal.

Mr. Protheroe advised the Court that it had now concluded all the business that was before this sitting of the Court.
