The 27th Meeting of the "School District No. 43 Joint Family Division Committee" was held in the Kyle Centre, 125 Kyle Street, Port Moody, B.C. on Thursday, September 28th, 1978 at 8:00 p.m.

The Deputy Chairman called the meeting to order and extended a welcome to Ms. Darlene Cross, Chairperson of the Coquitlam Justice Council, who was in attendance to apprise the Committee of the activities of the Justice Council, and also to Mrs. Bev Lefrancois representing the B.C. Council on the Family, who was in attendance to report on the Council's recent activities and future plans.

CONFIRMATION OF MINUTES:

Prior to passage of the foregoing resolution, the Deputy Chairman introduced a brief discussion regarding voting privileges and reminded those present that only 'appointed delegates of the Municipal Council' had such privileges.

Ms. Darlene Cross, Chairperson of the Coquitlam Justice Council was invited to address the Committee. Ms. Cross indicated that the Justice Council was relatively new to the area, being formed in November 1977, and consisted primarily of interested lay people dealing with youth and family problems resulting from persons encountering police, probation or Court officials. She further noted that the Provincial body, comprised of regional representatives from the entire Province, is a registered Society and functions as a 'lobbying' group for presenting the concerns of the local organizations to the appropriate Government Ministry. Funding is obtained through the Attorney-General's Department and from the Solicitor General and it was indicated that several thousand dollars was available at the present time for the financing of a special project deemed worthwhile by the Justice Council and approved by the A-G's Department. A general discussion of the various areas of the Council's involvement ensued and it was noted that at the present time, the Coquitlam Council is primarily youth oriented, perhaps due to the involvement of the Port Coquitlam Youth Council and representatives of the Coguitlam R.C.M.P. Youth Detail, Probation officers and Mental Health Service personnel. It was further indicated that at the present time there is no representation from the City of Port Moody and approximately 70% of the membership is from the Port Coguitlam area, the balance coming from Coquitlam. Ms. Cross emphasized that the Justice Council would welcome additional members at any time and suggested that the Family Division Committee may wish to send a representative to one of the meetings in order to have an exchange of information between the two Committees. The meetings are held bi-weekly at Noon, Mondays, in the Probation Offices, 1030 Westwood Street.

In thanking Ms. Cross for her presentation, Deputy Chairman Francis requested that Notices of Meeting of the Justice Council and any pertinent information arising therefrom, be forwarded to the Family Division Committee for information.

Mrs. Bev Lefrancois was then invited to address the Committee, and she advised that the B.C. Council for the Family had been in existence for approximately fifteen months and had been formed as a

result of two conferences held prior to that time by representatives of Government, religious organizations and interested community agencies and individuals who had expressed a concern over the great increase in marriage breakdowns and the general breakdown of family life throughout the Province. A brief outline of the early days of the Council for the Family was provided and it was indicated that at the present time, approximately \$40,000. from the Minister of Human Resources and \$20,000. from the various churches, provided the necessary operating funds for the Council and permitted a full-time Co-ordinator and two secretaries - the balance of the work being carried out by volunteers. Mrs. Lefrancois noted that in comparison to many other areas of the Province, School District No. 43 has a wealth of services available to the residents and her main objective was to make the people aware of the existence of the facilities and encourage the use of same. She indicated that many of the existing agencies are designed to deal with a problem after the fact, whereas the Council for the Family wants to start talking before the problem develops and work towards preventing the problem. A brief discussion was held regarding the programmes presently being promoted by the Council for the Family such as Family Month, Marriage Preparation programmes, Marriage Enrichment programmes, Family Home Evenings, etc.

Two of the upcoming programmes of the Council for the Family are the distribution of the 'White Paper on the Proposed Family and Child Services Act', which is presently being studied by the Ministry of Human Resources. The Council for the Family is asking that as much community input from all areas of the Province as possible be solicited and over 300 of the questionnaires are to be circulated within District #43. Mrs. Lefrancois indicated that she would encourage people to review the White Paper and be prepared to offer constructive criticism and suggestions for change. The second programme sponsored by the Council at this time is plans for 1979 International Year of the Child. They are looking for a wide-spread involvement of not only individuals and community organizations but the community as a whole in developing activities to advance the rights, interests and well-being of children and their families within society.

A futher comment was made that the Council has been endeavouring to study Bill 22 and its implications (i.e. the Family Relations Act) and the general consenus was that before any real comments could be

made a legal interpretation was required due to the terminology used in its writing.

Deputy Chairman Francis thanked Mrs. Lefrancois for her attendance at the meeting and advised that the Committee would assist in the circularization of the material on 1979 Internatinal Year of the Child to its membership and further that the Committee members would endeavour to participate in the review of the White Paper.

CORRESPONDENCE

Mr. Emerson referred to a letter from the Attorney-General under date of April 27th, respecting the 1977 Annual Report submission of the Committee and questioned the present status of the Unified Family Court Facility for Coquitlam. Following a brief discussion it was agreed that no further information was available at this time but that it should still be considered a priority item.

Ms. Kenmuir referred to the letter from the Coquitlam

Volunteer Bureau with reference to their need for new premises and

a brief discussion ensued with respect to the need for these premises

and avenues of investigation which might be pursued in order to render

assistance to the Bureau.

Moved by D. Kenmuir:

Seconded by M. Bouliane:

That if a concrete suggestion for location of new premises for the Greater Coquitlam Volunteer Bureau is received, the School District No. 43 Joint Family Division Committee is prepared to direct a letter of support to the application for use by the Bureau.

Carried.

OTHER BUSINESS:

A brief discussion ensued regarding the small number of persons in attendance at this meeting and it was generally agreed that more support was required by the members appointed by the respective Municipal Councils. It was suggested that perhaps if the Committee had a specific 'project' to work on, it would encourage more regular support of the members. At this time, the question of procedural problems being encountered in the Juwenile and Family Courts in Coquitlam was brought to the attention of the Committee. A

lengthy discussion ensued on the subject, following which it was agreed that a meeting should be held at an early date to devote the entire meeting to discussing this matter further.

That a letter be written inviting Judge W.S. Selbie to attend the next meeting of the Committee in order to discuss further the question of procedural problems being encountered in the Juvenile and Family Courts in Coquitlam;

AND THAT the dates of October 19th, October 26th and November 2nd be submitted for his consideration as suitable dates for the meeting.

A brief discussion confirmed that the depth of the subject to be considered by the Committee required that a regular meeting schedule be adopted.

Moved by A. Emerson:

That the Committee meet on a monthly basis until further notice - possibly every fourth Thursday.

Carried.

It was generally agreed that additional resource persons familiar with the subject under consideration be invited to attend and names were to be submitted to the Secretary as soon as possible.

Deputy Chairman Francis, at the request of Chairman Robinson, noted that due to the cancellation of the June meeting, the subject of sending a representative of Committee to the B.C. Council for the Family Conference had not been discussed and it was suggested that as Mrs. Bev Lefrancois had attended as a representative of School District No. 43, it may be in order to reimburse her for her expenses. A general discussion ensued as to the payment of expenses for members attending various workshops, seminars or conferences and it was agreed that in order for expenses to be paid the representative must be a member of the Committee and be specifically sent as a delegate representing the Committee.

Ms. Kenmuir requested that Minutes of the meetings be circulated as soon as possible following the meeting rather than as an attachment to the Notice of Meeting, and the Secretary agreed to change the procedure.



The Secretary advised that regrets had been received from K. Gillies. The Chairman advised that prior to the arrival of Judge Selbie, there were a few items to be dealt with by the Committee.

CONFIRMATION OF MINUTES:

Moved by S. Nichol:

Seconded by J. Cathie:

That the minutes of the regular meeting of September 28th, 1978 be taken as read and adopted.

Carried.

Ms. Kenmuir reported that further to the previous discussions regarding the Greater Coquitlam Volunteer Bureau's need for new premises, she was pleased to report that the Bureau has been allocated space in Vanier School and the Co-ordinator, Ms. Mossop, is apparently pleased with the premises provided. A brief discussion then ensued.

Mrs. Cathie referred to the discussion in the Minutes with respect to the next meeting and following a brief discussion it was agreed that the next meeting would be held at 7:30 p.m., November 23rd, 1978 in the Council Chambers of the Port Coquitlam City Hall.

Alderman Robinson indicated his regrets at the news that Port Moody Alderman Joan Homer would be leaving for Toronto at the end of the year and extended best wishes to her on behalf of the Committee.

Alderman Robinson suggested that the Committee have a brief discussion on the items of concern with respect to the procedural problems being encountered in the Coquitlam Juvenile and Family Courts which were to be discussed with Judge Selbie this evening and requested that Ms. Roest provide additional information at this time. Ms. Roest then submitted a report to the Committee along with suggestions as to the approach that the Committee may wish to take in discussing the matter with Judge It was generally agreed that first the present conditions and concerns of the Committee would be outlined for Judge Selbie, following which his comments would be requested. Finally, a decision would be made as to the action to be taken by the Committee in terms of resolutions, etc. Additionally, the Committee would be looking to Judge Selbie for advice with respect to the course of action to be undertaken by the Committee and to whom correspondence should be addressed with respect to this matter. Further it was agreed that follwoing the discussion, a decision should be made as to whether its deliberations on this subject should be made Ms. Kenmuir suggested that it would be beneficial to the Committee to solicit the opinions and comments from the other Family Division Committees in the Province and the Committee agreed to take this suggestion under advisement. Following another brief discussion it was concluded that the three main problems to be discussed were:

- 1. The continuous change of Judges on the Bench.
- 2. The quality of what is happening in the whole justice system with respect to family and juvenile matters.
- 3. The low priority of juvenile and family matters within the Court system.

A discussion ensued until 8:00 p.m. at which time a brief recess was called. At 8:10 p.m. the meeting reconvened with His Honour Judge W.S. Selbie in attendance.

Alderman Robinson thanked Judge Selbie for attending and briefly outlined the Committee's concerns with respect to the lack of continuity and consistency in the Judges sitting in the Coquitlam Family and Juvenile Courts and advised that the Committee wished to present its case and, following discussion, it was hoped that some positive action could be taken by the Committee with a view to improving the situation and respectfully requested guidance from the Judge in this respect. Additionally, it was indicated that if there was any way in which the Committee could support Judge Selbie in any of his programmes which would improve the system in Coquitlam, they would be more than pleased to render such assistance.

Judge Selbic advised that he had been an Administrative Judge in Coguitlam for the past three years and prior to that had served as a Family Court Judge in Vancouver. He further indicated that it had been his feeling for some time that a specialized Family Court system was needed and to this end he carried out an in-depth survey, approximately four years ago, which resulted in his concluding that not only was there a need for consistency of personnel in the Courts but also for some level of professionalism on the Bench. He was not prepared, however, to implement such a system in one local area as a 'band-aid' treatment of the problem and he felt that if changes could not be implemented on a Provincewide basis, he personally, was not prepared to take any action He pointed out that although almost every small community felt they were entitled to a 'specialized' Judge, it was difficult to justify the need for specialization for every small area where there were, perhaps, only one or two court days Judge Selbie further noted that the Resource people in these outlying areas are extremely important in that if the case is properly prepared and handled by the resource people, the problem can very often be resolved before reaching the Courts.

Judge Selbie then briefly reviewed the system as it presently exists in the Coquitlam area and discussed a few of the problems being encountered in scheduling for the next year. At this time a few of the more specific problems were considered with respect to the pros and cons of a 'unified family court' system, one of the main objections being the belief that clients object to drive any great distance to a facility. It was indicated, however, that if the client could be assured that their case would be placed before the Courts, by a 'professional' to be heard by a 'professional' (i.e. one that is particularly trained and interested in dealing with Family Court matters) perhaps some of these reservations could be overcome. Judge Selbie further noted, however, that the present system of numerous individual Courts throughout the Province could not support the professionalized system desired and in order to accommodate this proposal, some consideration and agreement to If the concept of centralized services would be necessary. centralized facilities is not acceptable, it is unlikely that a Unified Family Court system could ever be implemented. Discussion ensued with respect to the various aspects of the centralized/ unified systems in addition to the discussion of the degree and quality of legal services available to the Coquitlam Family and Juvenile Courts.

It was noted at this time, that Coquitlam is one of the few Courts where legal services are available to both the Juvenile and Family Courts and even though it is usually carried out on an ad hoc basis, it is appreciated by those involved in the system as resource personnel and the clients themselves. In most instances legal counsel is available to all of the Juvenile Courts presently being held in Coquitlam.

A brief discussion of the requirements of the 'unified' family court system in the Coquitlam area ensued, which included a discussion of the building requirements and it was noted that the decision as to the location of the facility was a very political one and therefore until a decision was announced by Victoria as to the location of the facility in the Coquitlam/Port Coquitlam area, little action would be taken with respect to implementing such a system due to the lack of specialized facilities.

In speaking to the subject of the unified court system, Judge Selbie suggested that if the Committee was in support of the concept, it would be advantageous to contact the Family Division Committees of Burnaby and New Westminster to solicit their support of the concept in order that a stronger case can be presented for implementation of the unified (or integrated) court system in this area. Alderman Homer requested that a copy of the study carried out by Judge Selbie be made available to the members of the Committee so that the concept of the unified/integrated court system can be more fully understood by all members of the Committee.

With respect to the comments on the lack of efficiency in scheduling appearances and the problems involved in having lengthy waits in inadequate waiting facilities, Judge Selbie agreed to speak to those concerned in an attempt to alleviate some of the delays although, due to the nature of the problem, he could not guarantee a complete solution.

At 9:25 p.m. a brief recess was called while Judge Selbie left the meeting. Prior to his departure, His Honour advised that he had been very pleased to attend the meeting and requested that he be contacted if he could be of further assistance to the Committee in its deliberations on the subject.

After reconvening the meeting, Alderman Robinson reviewed several alternatives open to the Committee at this time:

- 1. the hosting of a joint meeting of Family Division Committees in the area;
- 2. dealing specifically with the problems in our area with respect to the Court system and include problems dealing with both the Staff and the physical plant;
- 3. dealing with the situation of the lack of staff prosecutors and the use of ad hoc personnel.

Following a rather lengthy discussion of the alternatives available it was:

Moved by D. Kenmuir:

Seconded by J. Homer:

That a letter be written to the Attorney-General advising that the School District No. 43 Joint Family Division Committee is in the process of reviewing procedural problems which presently exist in the Juvenile and Family Courts in Coquitlam and will be making a formal presentation on the subject in due course;

AND THAT in the meantime, the Attorney-General be requested to give priority consideration to the need for implementing a system of permanent legal counsel in the Coquitlam Juvenile and Family Courts.

Carried.

Mr. Maddalozzo suggested that clarification be obtained regarding what actually happend in a unified court system and further suggested that a representative of a unified court system be invited to attend the next meeting of the Committee. The extension of an invitation to representatives of other Family Division Committees in the area was also considered and it was left to the discretion of the Chairman as to which meeting these representatives would be invited.

Mr. Emerson agreed to submit some literature he had available regarding the justice system and the unified court system to the Secretary for circulation prior to the next meeting.

Following discussion it was agreed that the Family Division Committee, as constituted, has considerable influence with the Provincial Government and this influence must be exercised in the best interests of all citizens within its jurisdiction.
